CARBON EMISSIONS REDUCTION POLICY

This policy is part of the MCS Code of Ethics and is to be read in conjunction with our Social & Ethical Policy for Corporate Responsibility, Competition Law Compliance, Sustainable Development, Security Measures & Risk Management, Avoidance of Counterfeit Materials and Safeguarding policies, along with our commitment to SA 8000 Social Accountability and the Global Compact.

This policy is practised throughout our organisation from recruitment, through selection, training, promotion, discipline and dismissal.

At no stage in the past has the company or any of its Directors or employees been guilty of any social or ethical infringements.

MCS Control Systems Limited is a well respected business in Electrical & Electronic Engineering and Industrial Software Solutions. The Company has built a reputation on providing a professional and trustworthy service throughout the U.K. maintaining the highest standards of engineering skills.

Our environmental policy and practices show that we take our responsibility very seriously, to ensure the safety of our operations, minimise the impact on the environment and to conserve natural resources.

MCS have carried out a review of the Aspects and Impacts and recognised those aspects which have the most significant impact. These are recorded on the Significant Aspect Register (SF095), which is available upon request.

Although the company does not have any major significant aspects, those recorded have been used as the mainstay for our environmental procedures and have enabled us to put the necessary control measures in place, to minimise the impact on the environment.

MCS has produced this Carbon Emissions Reduction Policy in order to support all of our other Environmental and related policies.

Purpose of the Policy

Climate Change, the Greenhouse Effect and Global Warming are real issues affecting the entire world and the current state of the climate crisis demands that all companies make efforts to reduce their carbon footprint.

Doing this will pose unique challenges that will require an unprecedented degree of commitment and cooperation by industrial world.

The purpose of this policy is to provide guidance and direction to address these challenges and to establish MCS as a participant in carbon reduction.

Policy

It is the company's policy to concentrate its efforts in the three major areas responsible for most of the company's emissions: Heating, Electricity and Transportation.

Heating

MCS will make it a priority to decrease emissions resulting from the generation of heat for all buildings. This is to include:

- Switching to lower emission fuel sources, wherever possible, as these become available and represent viable options and using alternative energy sources, where these sources are appropriate
- Implementing energy efficiency measures wherever possible
- Working with employees to reduce the ambient temperature of buildings.

Electricity

MCS will make it a priority to decrease emissions through a reduction of the use of electricity. This is to include:

- Retrofitting buildings with energy efficient technology wherever it is reasonable to do so
- Purchasing high efficiency / low energy equipment and computer hardware with energy saving settings
- Working with employees to reduce their use of electricity.

Transportation

MCS will make it a priority to decrease emissions resulting from company vehicles. This is to include:

- Reducing the number of vehicles where it is appropriate to do so
- Gradually replacing the existing fleet (over time) with low emission, alternative-fuel vehicles, where it is appropriate to do so
- Implementing a journey planning system and use satellite navigation systems to reduce travel distances
- Working with employees to consider their travel requirements.

CARBON EMISSIONS REDUCTION POLICY

Performance Indicators, Accountability and Targets

The management will collect information and report progress on emission reduction in the annual Management Review Meeting. The measures to be considered are:

- Fossil fuel use and emissions from heating processes
- Electricity use and emissions from annual electricity consumption
- Fossil fuel use emissions from transportation
- General energy consumption and emissions

MCS will:

- Establish a baseline by 31st December 2010, for the indicators noted above and
- Establish interim targets by December 31, 2011, for goals and actions for 2012, 2015 and 2020 and other years to 2039.

This policy will be kept up to date, the policy and the way in which it has operated, will be reviewed every year.
